Based on a review of our current State Funded services budget, PBH will make the following changes to state funded services:

a.) Effective April 1, 2010, State Funding will end for the following services:

b.) Effective May 1, 2010, State Funding will end for the following services:

c.) Effective April 1, 2010, State Funded Outpatient benefits will be limited to eight (8) sessions for adults and twelve (12) sessions for children. This change does not apply to Medication Management (service code 90862). The number of sessions shall be counted as those that have been provided on or after July 1, 2009.

State Funded services are based on the availability of funding and are not an entitlement. These changes do not create an administrative appeal right.
